Siskiyou County Public Defender	The Public Defender's Office provides legal counsel to indigent persons who have been charged with committing a felony or a misdemeanor. If you are charged with a crime and cannot afford an attorney, you can ask the Superior Court judge to appoint the Public Defender to represent you. The Court initially determines whether or not a person is "indigent" or financially incapable of hiring a private attorney. This usually takes place at the first court appearance. You are asked if you can afford an attorney and, if not, you fill out a financial form.
